The 87th Annual Coleman PRCA Rodeo will be hosting Kid's Mutton Bustin'. Mutton Bustin' has become a popular addition to Rodeo Performances and is similar to the Grown-up Cowboy rough stock except that the youngsters will ride SHEEP. Contestants must weigh **55 pounds or less** to be eligible. Fifteen contestants compete each night of the rodeo prior to rodeo performance. Each child will receive an official Mutton Bustin' T-shirt for participating. The T-shirts are donated by Coleman Rodeo Association. The contestant with the highest marked score each night will receive a Champion Belt Buckle sponsored by the Rotary Club.
